Auditor General for Wales' Audit Certificate and report

I have conducted my audit on behalf of, and in accordance with, guidance issued by the Auditor General for Wales. On the basis of my review of the Annual Return and supporting information, I report whether any matters that come to my attention give cause for concern that relevant legislation and regulatory requirements have not been met.

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2018 of:

External auditor's report

I am required by law to satisfy myself that:

- the council's accounts are prepared in accordance with the Accounts and Audit (Wales) Regulations 2014;
- the accounts comply with all other statutory provisions applicable to the accounts;
- proper practices have been observed in compiling the accounts; and
- that the council has made proper arrangements for securing economy efficiency and effectiveness in its use of resources.

On the basis of my review carried out in accordance with the Auditor General's Code of Audit Practice, no matters have come to my attention to give cause for concern that the council's accounts are not prepared in accordance with the Accounts and Audit (Wales) Regulations 2014 and that proper practices have not been observed in compiling the accounts.

In its Annual Governance Statement, the Council states that it has taken steps to ensure that there are no matters of actual or potential non-compliance with laws, regulations and codes of practice. In my opinion, this assertion is not correct.

- The Council has incurred expenditure of £4,325 related to planning consultancy fees. I consider this expenditure to be unlawful because the Council has failed to comply with its standing orders and financial regulations related to procurement.
- In continuing to engage the services of one supplier without further market testing, the Council has not made proper arrangements to secure the economy, efficiency and effectiveness in its use of resources.

Further information on these matters is included in the Auditor General's report in the public interest issued on 6th November 2019.
