Cllr Rob Marshall – Manifesto for Chair of Culture, Tourism and Communications Committee

I wish to put my name for the position of Chair of the Cultural, Tourism and Communications Committee. It is a position I have held before and the CTC committee under my chair ship has always been known as the fun and friendly committee - where nastiness and hostility are not welcome and everyone is listened to. Our successful flagship event 'Mumblesfest' has grown from an idea of a music festival that I brought to the then events committee. Last year saw our most successful Mumblesfest yet and I am hoping that this years will be just as great. For those who don't know me that well I am a concert pianist by profession and have travelled extensively throughout the UK and Europe playing solo recitals, chamber music and concertos with orchestras. Being well travelled with my job means that I have been able to see how other cities and indeed countries value, respect and implement culture in their daily life through their communities, and I have built up a strong network of arts professionals throughout Europe and beyond. As well as working as a concert pianist and teacher of music I also work as a music producer and have many TV and Radio credits to my name and a strong circle of friends and colleagues who work across the arts discipline.

I would very much like us as a council to work on a strategic tourism plan. We are a tourist destination and also a central base for visitors travelling to West Wales, Brecon Beacons, Aberystwyth, and Cardiff. I believe we are capable of delivering an ambitions series of events throughout the tourist season along with supporting independent and community groups to share with this vision. Being a child of the village I have seen Mumbles go through different phases over the years and my goal will be for us to deliver for tourists whilst not forgetting our residents who live here all year round. I am a big believer in teamwork and working together for a common goal. and I recognise there are some members of MCC that bring a great deal of



experience and to areas of the portfolio that I am lacking. Again I see this role of as a coordinator of people, not always taking the lead myself if someone is better suited. Lastly I have excellent relations with not just our own officers but also officers and Cabinet Members at CCS who are only too happy to meet with me and discuss joint projects to work on.

Cllr Helen Nelson - Manifesto for Chair of Environmental Committee

I'd like to put myself forward for chair of the environment committee again. I feel that Lydia and new Groundsperson Martin, need support and continuity at this time whilst we're without a clerk, which I'm happy to continue to provide.

These two new staff particularly need a period of consolidation and foundation building. This isn't the year for lots of new schemes, but must be about making the sites, decisions, and activities that we have already committed to work well. And to communicate that better to the whole community.

Whoever is chair will also need to respect the work priorities that have already been agreed in committee, and in our budget by full council.

2022 has been a challenging year. The election, then Jasmine leaving, then Meg so soon after we'd recruited her, and then loss of Steve has meant that it's been almost impossible to gain any momentum. It's felt like one step forward and two steps back.

In 2023, I will:

- Help the staff and committee to focus and deliver what's set out in the budget. To this end, I've been working with Lydia on her work plan, and I had liaised with Meg on the site management plans.
- Help the environmental staff to understand what part they need to play in the work of other MCC committees. This hasn't been clear in the last year (eg Mumblesfest, Skatepart for example), often leading to confusion and unclear expectations.
- Communicate better MCC's environmental achievements; I am helping to rewrite the environmental pages of the MCC website.
- Encourage other committee members to be more involved in certain aspects of the committee's work to help share responsibility
- Try and keep monthly committee meetings shorter.
- Ensure that there's capacity for MCC staff to help deliver against the projects in the committee budget. This isn't always the case in my experience (last year).

Firstly I would like to ensure that we market our grants scheme more widely and attract applications from a more diverse range of local community groups.

Secondly, I want to ensure that training opportunities are taken up both by councillors and staff and will ensure that our annual training plan provides real opportunities for us to provide the breadth of training to meet the increasingly diverse needs of the Council.

Thirdly, I would like to ensure that we review the Community Regeneration Strategy produced by our External Evaluator in 2020 and to ensure that as a council we undertake annual evaluations of our work.

I will also continue the work started to review our policies and procedures which we are very aware that some are out of date now or do not fit with the changing needs of the Council and our Community.



I have been closely involved, as a member of the Ostreme Work Group, in the planned redevelopment of the Ostreme and would wish to see that work progressing with the full involvement of the council and the community.

Finally I have a wide experience of grant funding, of managing large budgets, managing a team and project management and feel that these skills will be of real value to the role of Chair of Finance & Compliance Committee.
