



Minutes of Meeting of the Environmental Committee held on 27 November 2023 at 6.30 pm Hybrid Meeting at the Ostreme Centre & via Teams

EN2311-03 Big Climate Leap – Presentation from Natasha Dodds (project lead from The Environment Centre)

Natasha Dodds provided a 'Powerpoint' Presentation, the content of which had been previously circulated to committee members. Following the presentation Natasha answered questions from members before departing at 7.11pm

AGREED that the implementation of recommendations and practices contained within Natasha's presentation will have a significant bearing on the future decision making and collaboration with others by MCC.



EN2311-04 To approve the minutes of the meeting held on the 23 October 2023 as a true record.

Prior to the minutes of the meeting held on 23rd October 2023 being agreed, the Chair, Cllr. Nelson raised concerns over the minutes prepared by The CSO in relation to the meeting held on 2nd October 2023. In particular whether a discussion concerning the proposed installation of a 5G Mast in Mayals had been sufficiently recorded including details of those being present together with reference to declarations of interest. The discussion concerning The 5G Mast had taken place prior to the committee meeting due to it not being quorate at that time.

The CSO updated the committee on all outstanding actions having previously circulated the full list of 'actions' to committee members.

EN2311-06 Budget Monitoring Report to 30/09/2023

Reports attached.

Paul Beynon, The RFO outlined key points from the Budget Monitoring Report. The RFO addressed questions from councillors including grants available to primary schools and grass verges within MCC.

RESOLVED the Budget Monitoring Report was accepted.

Action: Lydia to make one further attempt to contact primary schools in relation to them utilising environmental grant money of £500 per school

Action: Martin Russell to update the Committee on grass verges at the December Meeting.



Action: CSO to liaise with Martin Russell over his expenditure, ensuring that he claims all the expenses incurred.

Recommended that the Environment Committee is authorised to spend up to £1,000 organising the Mumbles Gardener's Question Time event to be funded from the Mumbles Gardener's Question Time budget (ENV 27).

EN2311-07 Budget 2024/25 to be presented by Paul Beynon, RFO

Paul Beynon, The RFO, outlined current and future budgeting considerations including the need for budgeting proposal forms to be submitted in a timely manner. In answer to questions from participants The RFO confirmed that the expenditure on the spreadsheet only related up to 30th September 2023.

The Chair, Cllr Nelson set out ideas for budget proposals on behalf of herself and Cllr Parkin. Some of the ideas including bulb planting would in all probability be included within plans being prepared within the budget for The Big Climate Leap. Other ideas included acquiring an electric van for use by Martin Russell and training sessions being provided by Green Heros. The use of an electric van generated a discussion on how the vehicle would be charged and stored overnight.

During this discussion Cllr Emelie Cox left the meeting at 7.44pm.

Action: Lydia to liaise with Martin over the price of bulbs and update RFO who will decide whether a budget proposal form is necessary for any additional costings.

Action: Cllr Nelson to consider budget items in consultation with RFO and circulate a list to all committee members prior to December Meeting.

Action: Cllr Townsend Jones to research possibilities of charging and storing an electric vehicle overnight at Ostreme or another site.

AGREED that all Budget Proposal Forms be provided to RFO before 1.12.23 in order that any proposal be agreed at December's Committee and Full Council Meetings.



RESOLVED the Draft Budget Spreadsheet was accepted.
