Budget Monitoring Reports to 31/07/2024 - Paul Beynon, RFO

FI2409-05

Financial reports prepared by RFO Paul Beynon which had previously been provided to councillors. The RFO outlined in relation to small and medium sized grants, that following expenditure up to the current time £15,600 remained available until the end of March 2025 (end of financial year). No queries regarding these reports were raised by councillors.

FI2409-07

Cardiac Risk in the Young (CRY) Grant Application

Grant Application for £5,000 to contribute towards the screening of 100 young persons aged between 14 and 35 in relation to identifying heart-related issues.

This application had been discussed at July's Meeting and had been deferred to allow the applicant to provide additional information. The applicant had provided this information and Cllr Erasmus, who had declared a personal interest due to her friendship with the applicant also elaborated on the success of the project. Health screening had taken place in Newton Hall in 2023 and identified potentially vulnerable individuals. A discussion took place in relation to MCC's role in assisting a national charity albeit with direct local connections. Other issues connected to this application related to the role of NHS in identifying persons at risk, particularly those from families where pre-existing conditions exist. More general concerns arose in discussion including whether MCC should contribute to national charities, whether other community councils are receiving similar requests for grants covering the same project and whether collections should be made for such charities at events arranged by MCC.

RECOMMENDED that Full Council make a decision in relation to this grant application.

RECOMMENDED that advice be sought through Full Council for guidance on how MCC should contribute to national charities in relation to future grant applications.



FI2409-08

St John's Ambulance Gower Division Grant Application

Grant Application for £5,000 to contribute towards the purchase of vital equipment for volunteers and includes expenditure for training

The Chair, Cllr Marshall outlined how a response had been received from the applicant in relation to queries raised at July's Meeting. The applicant confirmed that other grant applications had been made although further details had not been provided. In relation to discounts on services provided to MCC by St John's Ambulance, the applicant was prepared to offer a discount of 15% for training and 10% at MCC-related events in exchange for this grant application being successful.

RECOMMENDED that Full Council make a decision in relation to this grant application.

RECOMMENDED that advice be sought through Full Council for guidance on how MCC should contribute to national charities in relation to future grant applications.

FI2409-09

Kids Cancer Charity Grant Application

Grant Application for £1,000 to support families in Mumbles who have children diagnosed with cancer respite breaks.

A discussion again took place in relation to the role of MCC in relation to national charities and how guidance was required from One Voice Wales. Such advice having been recommended in the previous two agenda items.

The Chair, Cllr Marshall proposed that this grant be recommended on the basis that two beneficiaries had been identified, namely two families living within MCC and that the grant money requested was relatively small in relation to the two previous grant applications.

RECOMMENDED to approve a grant application for £1,000 be provided to support families in Mumbles who have children diagnosed with cancer respite breaks. **(Budget FC1)**



FI2409-10 Sunday Tea Room Grant Application

Grant Application for £425, to provide elderly residents of MCC with monthly Sunday afternoon tea.

Cllr Townsend Jones outlined that although a national charity 'sign-posted' individuals to local charities the application related to a local and autonomous charity with no national oversight involved.

FI2409-11 Oystermouth Historical Association Grant Application
