C02305-02 Declarations of Interest

C02305-03 Public Participation

There was no public representation at the meeting.

C02305-04 Digital Archive - Phase 3

Following a brief introduction by Cllr Will Thomas on the Mumbles Digital Archive Programme; Bev Rogers supported by two volunteers Josie and Barbara gave a short update on the progress of the project. The archive has been named 'The Story of Mumbles' and this website will contain a variety of formats including photographs, stories and posts. There are currently 33 volunteers whose ages range between 17 and 92 inputting information. Each entry is cross references with different categories e.g. pubs, bridges, beaches. It is a lengthy process with each image taking about 10 minutes to complete.

The website contains in the region of 500 items and will be launched once an acceptable number of items have been updated onto the website. The decision to launch will be taken by the Archive Sub-Committee who are best placed to judge when sufficient items are recorded on the website.

RESOLVED To approve the payment of £1,000 pcm from the CTC12-Digital Archive Budget to MCC's heritage coordinator for up to 12 months for what will be known as phase three of the digital archive. The progress is to be monitored by the culture, Tourism and Communications committee of the council.

Relocation of MCC Benches

During the Pandemic MCC purchased 20 picnic benches which have been placed at Southend Gardens. Following the end of the pandemic these benches need to be relocated. This agenda item only relates to these benches and not the benches along the seafront impacted by the sea defence programme.

Discussion focused around how best to share the benches around the different wards including the new skate park development.

RESOLVED that each ward be allocated five benches.

Grant Application

Wholeness Dance - Amended Grant Application Grant application for £3,318 towards the Mumbles Movers and Groovers Project which is for ages 60+ and incorporates specific exercises to improve strength, mobility, balance and flexibility and is designed to reduce falls in the elderly through the fun medium of dance discussed. The payment would be made from the Small and Medium Grants (FC1) budget.

The overall cost of the programme exceeds £6,000 with the majority of costs being the renting Ostreme and staff wages. Similar courses are run elsewhere in Swansea and it is believed that the project will primarily benefit residents within the MCC catchment area. The application is based on at least 20 participants contributing £4 per session. The main concern for councillors focused on the conflict between providing a valuable service for elderly residents against not supporting similar funding to other worthwhile projects. In the future a reduced or no rent arrangement may be possible when MCC are responsible for Ostreme Centre

RESOLVED It was approved that the application be agreed as a 'pilot' programme. A grant of £829.50 for the first quarter (12 weeks) of the project from budget FC1 Small and Medium Grants to be paid with a review to be conducted prior to the end of that period.

RESOLVED that £1,500 should be made available from the contingency budget for eventualities in relation to legal and survey fees connected to Underhill Development. Also, that a letter (drafted by Cllrs Townsend Jones, Thomas, Fogarty and Thomas) seeking to resolve the issue of Mumbles Rangers playing at Underhill Park be sent to all interested parties including MCA.

CO2305-09 Cais am Grant

Wholeness Dance – Cais grant diwygiedig am grant o £3,318 tuag at brosiect 'Movers and Groovers' y Mwmbwls, sydd ar gyfer pobl 60 oed ac yn hŷn ac sy'n cynnwys ymarferion penodol i wella cryfder, symudedd, cydbwysedd a hyblygrwydd ac sydd wedi'i gynllunio i leihau codymau ymhlið yr henoed trwy'r cyfrwng hwyliog a drafodwyd, sef dawns. Byddai'r taliad yn cael ei wneud o'r gyllideb Grantiau Bach a Chanolig (FC1).

Mae cost gyffredinol y rhaglen yn fwy na £6,000, a'r rhan fwyaf o'r costau yw rhentu Canolfan Ostreme a chyflwyno staff. Cynhelir cyrsiau tebyg mewn manau eraill yn Abertawe a chredir y bydd y prosiect o fudd i drigolion o fewn dalgylch Cyngor Cymuned y Mwmbwls yn bennaf. Mae'r cais yn seiliedig ar o leiaf 20 o gyfranogwyr yn cyfrannu £4 y sesiwn. Roedd y prif bryder i'r cynghorwyr yn canolbwytio ar y gwrthdarw rhwng darparu gwasanaeth gwerthfawr i drigolion oedrannus yn erbyn peidio â chefnogi cyllid tebyg i brosiectau gwerth chweil eraill. Yn y dyfodol, efallai y bydd trefniant rhent llai neu ddim rhent yn bosibl pan fydd Cyngor Cymuned y Mwmbwls yn gyfrifol am Ganolfan Ostreme.
