220.06 Local Development Plan - OY003 Thistleboon Caravan Park

A motion was proposed by Cllr Griffiths and seconded by Cllr Cooper:

RESOLVED that MCC objects to the proposed amendment to incorporate Candidate site OY003 Thistleboon Caravan Park within settlement boundary on the following grounds:

- 1. The settlement boundary was moved in the LDP map issued in December 2014 without any reference to the change made on the map or any form of notification to MCC about this proposed change to its settlement boundary.
- 2. The proposal to move the edge of settlement boundary on Mumbles Hill to include candidate site OY003, the caravan site, would be detrimental to the long term preservation of the Mumbles Hill Nature Reserve
- 3. The LDP deposit version of the ANGS map for Oystermouth, also issued in December 2014, clearly defines site OY003 as being within and totally enclosed by the Mumbles Hill Tier 2 ANGS, which includes Mumbles Hill Nature Reserve, a protected Green Space within the LDP.
- 4. The Candidate Site Assessment Report site map for OY003, dated 11/05/15, shows the AONB boundary to clip the NE corner of the site; whereas the extant boundary as defined within the UDP encompasses virtually the entire site.
- 5. In the Assessment Report comments relating to candidate site OY016, Thistleboon it is clearly stated that site OY003 is considered to be a development site.
- 6. MCC objected to development on this site during the candidate site consultation.

RESOLVED that MCC instruct CDN Planning to document MCC's objections to the proposed settlement boundary changes and place them before the Planning Committee prior to its meeting of 11th June 2015.

243.06 Newton Road TRO

244.06 Christmas Tree at Blackpill

Following a site meeting with Western Power and C&CS: Cost of supplying power received as £946.58

245.06 Fence at Jubilee Gardens

Quotation of £2,800 received from C&CS for green fence to be erected at Jubilee Gardens to replace the dangerous existing fence. The Development Committee agreed that this quote be accepted immediately due concerns about child safety as children have been seen playing on the existing, dangerous, fence.

RESOLVED that retrospective authority be given for the purchase and erection of the fence at the Jubilee Gardens at a cost of £2,800.
